

**Municipal Records Retention Schedule M6
ELECTORS AND ELECTIONS RECORDS**

The disposal of Election Records falls under the provisions of *CGS* Sec. 7-109. The Public Records Administrator may not grant blanket approval to destroy public records. You may obtain approval to destroy these records using the Form RC-075. The only exception to this rule applies to absentee ballots or unused or mutilated ballots. ***Be sure to read the notes included in this records retention schedule.*** These notes give specific destruction instructions. **Please note that a statutory citation included with a retention period indicates the retention period is prescribed by the statute cited.** The election calendar issued by the Secretary of the State is not a records disposal authorization.

TOWN CLERK -- FEDERAL REQUIREMENT: *In elections for federal offices—whether general, special, or primary—federal law (42 U.S. Code 1974) requires retention of all election materials for twenty-two (22) months after the date of the election, excluding unused, mutilated or voided ballots. This requirement supersedes any state statute or regulation.*
